### Welcome

Welcome to Arizona State University's Professional Science Master's (PSM) program in Forensic Science (Online). The PSM in Forensic Science will ready students for career advancement by providing them with greater educational depth and breadth in the forensic sciences and through the development of new competencies related to laboratory supervision and management. Our program is designed to instill advanced skills in scientific inquiry as well as critical laboratory leadership that will ready students for administrative and advancement opportunities. The PSM also trains students on how to work with regulatory bodies that provide the framework for oversight in forensic laboratories.

This program requires 30 credit hours of coursework, which includes a 6-credit hour culminating experience. The program requires students to follow the prescribed 4-semester course sequence. It is critical that you review this handbook thoroughly to ensure the successful completion of all requirements.

Arizona State University comprises sixteen colleges and schools spread across four campuses in the Phoenix, Arizona metropolitan area. The online PSM program in Forensic Science is offered by the School of Mathematical and Natural Sciences, which is part of the New College of Interdisciplinary Arts and Sciences at ASU's West Campus in Phoenix, AZ.

### Statement






### Student Body

## **Academic Requirements**

#### **Degree Requirements**

The Forensic Science PSM consists of 30 graduate-level (500-level or above) credit hours. Please review the ASU Office of Graduate College at <u>https://graduate.asu.edu/current-students/policies-forms-and-</u> <u>deadlines/policy-manuals</u> regarding Pre-Admission Credit. The Program Director must clear all such courses.

The program requirements include:

FOR 656: Laboratory Leadership, Policy, and Practice

#### **Required Forensic Science Courses (15 credit hours):**

FOR 501: Forensic Toxicology OR FOR 532: Principles of Pharmacology

FOR 502: Forensic Botany OR FOR 503: Forensic Entomology

FOR 540: Advanced Topics in Human Forensic DNA

PSY 546: Advanced Forensic Psychology OR CRJ 537: Criminal Procedure of Investigations for Social and Forensic Scientists

FOR 540: Quantitative Methods in Forensic Science Research OR BMI 515: Applied Biostatistics in Medicine and Informatics OR HCD 501: Biostatistics and Fata Management

#### Culminating Experience (6 credit hours):

FOR 593: Applied Project

#### Sample of Recommended Course Sequence

All work towards a master's degree must be completed within six consecutive years.

# Plan of Study

The Interactive Plan of Study (iPOS) functions as an agreement between the student, the academic unit, and the Graduate College. The iPOS contains certain requirements such as coursework, a committee, and a culminating experience which must be included before it can be approved.

To facilitate program completion and shorten time to complete the program, graduate students are encouraged to complete their iPOS in their first semester. Students who have not completed their iPOS by the time they have enrolled for 50 percent of the minimum credit hours required for their degree program will receive a registration hold. No student will be allowed to register for the culminating experience without an approved and up-to-date iPOS on file.

If a student needs help with filing the iPOS, the student can contact the Graduate Staff Advisor, and/or download the iPOS training manual.

Your iPOS will be reviewed by faculty and staff to ensure that it meets the Academic Requirements as outlined in the degree requirements of this handbook.

All courses that appear on the iPOS are applied toward the PSM degree and are ineligible to be applied toward a future graduate degree. As such, we recommend that students list only the 30 credits required for the PMS degree on the iPOS.

### **Culminating Experience**

Students will be required to complete an applied project on one of the subject areas (below) that will culminate as an electronic scientific poster that needs to be presented online.

- FOR 501 Forensic Toxicology
- FOR 502 Forensic Botany
- FOR 503 Forensic Entomology
- FOR 532 Principles of Pharmacology
- FOR 540 Advanced Topics in Human Forensic DNA
- FOR 560 Quantitative Methods in Forensic Science Research

Students must meet the following criteria to be eligible to enroll in and complete the FOR 593 course.

1) Up to date iPOS on file

2) Graduate GPA, Cumulative GPA, iPOS GPA must all be at 3.00

3) All required core and required courses must be completed BEFORE enrollment override of the culminating

experience

4) Students will be taking FOR 593 in their final semester

• If a student does not meet one or more criteria above, they may not be able to register for FOR 593 and could be removed from the course.

### Satisfactory Academic Progress Policy

It is the responsibility of the graduate student to be aware not only of the program's requirements but also policies set in place by the Graduate College. Students are required to be aware of and understand the current <u>ASU Graduate Policies and Procedures</u>, the New College of Interdisciplinary Arts & Sciences <u>Satisfactory Academic Progress Policy</u>, as well as any policies outlined in this manual.

In addition to requirements outlined in New College Satisfactory Academic Progress Policies, students must achieve a grade of "C" or higher in all *required courses* that appear on the approved iPOS (required courses are listed in the <u>ASU Academic Catalog</u>). A student who receives a C- or lower in a core course in their program must repeat the course in a regularly scheduled (not an individualized instruction) class. Although only the "C" or higher can be included on the iPOS GPA, both grades will be used to compute the Cumulative GPA and the Overall Graduate GPA.

### Student Code of Conduct
