Welcome to Arizona State University's Master of Science program in Psychology (Online). We have designed this program to give our students a strong, theory-based foundation in the modern field of psychology. Our program emphasizes quantitative methodology, statistical analysis, and professional development. We further offer a variety of seminar courses on a wide range of psychology topics. Many other of our students are looking for non-academic careers in government, education, behavioral health, and marketing. <a href="PLEASE NOTE">PLEASE NOTE</a>: This program does not provide hands-on research experience and it is not a pre-doctoral program.

This program requires 36 credit hours of coursework, including a capstone course. The program can be completed in as little as 12 months or at your own pace.

Arizona State University comprises sixteen colleges and schools spread across four campuses in the Phoenix, Arizona metropolitan area. The MS program in psychology is offered by the School of Social and Behavioral Sciences, which is part of the New College of Interdisciplinary Arts and Sciences, and is housed on ASU's <u>West Campus</u> in Phoenix, AZ.







### **Admissions**

Admission to the online MS Psychology program is offered for the following sessions, five times a year: Fall A (August), Fall B (October), Spring A (January), Spring B (March), and Summer A (May). The program uses a rolling admission deadline and admission decisions are typically made within two weeks of files being completed. Prospective students are strongly encouraged to initiate and complete the application at least one month before the listed deadline.

# **Tuition Costs and Financial Aid**

Tuition is set by ASU and the Arizona Board of Regents every year. You can see the general tuition and fees chart by <u>clicking</u> here, or calculate your specific tuition costs by visiting ASU's tuition calculator.

Course Assistant Positions: These positions typically assist with undergraduate courses that are offered online. Courses are typically half-semester (7.5 weeks at 20 hours per week) and a few are full semester (15 weeks at 10 hours per week), and CAs are paid a flat \$2,500 stipend for each course. Calls for applications will be sent out via email prior to the start of each session, when applicable. Although these positions are not guaranteed, most students who desire to serve as a CA have done so in one or more classes per year.

# **Funding for Travel and Research**

Although you do not have the opportunity to engage in research in this program, some online students may have the opportunity to present research (they are doing on their own with affiliated program faculty or faculty at other universities) at national and international academic conferences. Additionally, although this program is not designed to aid your admission to doctoral programs, if you apply and receive an interview, you may be able to apply funds towards travel expenses for doctoral program interviews. As with the other funding requests, the Program Director must approve this request.

The online MS Psychology program makes available approximately \$750 in travel and poster printing funding to each student, to be used over the course of their time in the program (not to exceed three years). These funds can be used in a one-year timespan or the student can choose to split it up over the duration that they are in the program. # **Academic Requirements**

### Degree Requirements & Culminating Experience

#### Admitted Fall 2021 or later

The online MS in Psychology consists of 36 credit hours of graduate level (500-level or above) credit hours. Please review the ASU Office of Graduate College at <a href="https://graduate.asu.edu/current-students/policies-forms-and-deadlines/policy-manuals">https://graduate.asu.edu/current-students/policies-forms-and-deadlines/policy-manuals</a> regarding Pre-Admission Credit. All such courses must be cleared by the Program Director and the ASU Graduate College. The program requirements include:

### Required Core (6 credits):

- PSY 502 Professional Issues
- PSY 513 Fundamentals of Quantitative Methods

#### Research (3 credits):

- PSY 500 Research Methods

#### Foundational Courses (15 credits):

- PSY 550 Advanced Social Psychology
- PSY 598 Advanced Cognitive Science
- PSY 598 Cross-Culture Psychology
- PSY 598 Advanced Developmental Psychology
- PSY 598 Advanced Positive Psychology

#### Elective Courses (9 credits):

Approved elective courses are offered on a rotating basis.

#### Culminating Experience (3 credits)

Students admitted in Fall 2021 or later will complete a required capstone experience course (PSY 553) and must pass with a grade of a "B", or better, to successfully complete the program and graduate. The culminating experience must be completed during a student's last semester of study. Students must meet the following criteria to be eligible to enroll in and complete their culminating experience:

- 1. Up to date iPOS on file
- 2. Graduate GPA, Cumulative GPA, iPOS GPA must all be at 3.00
- 3. All Core PSY courses must be completed prior to enrollment override of the culminating experience
- 4. Students can take ONE PSY foundational **OR** ONE elective course with their culminating experience

If a student does not meet one or more criteria above they may not be able to register for PSY 553 and/or may be removed from the course.

All work towards a master's degree must be completed within six consecutive years.

### Plan of Study (iPOS)

The Interactive Plan of Study (iPOS) functions as an agreement between the student, the academic unit and the Graduate College. The iPOS contains certain requirements such as coursework, faculty committee, and a culminating experience which must be included before it can be approved. **NOTE:** Dr. Kristin Mickelson will serve as the chair for the faculty committee section of the iPOS.

To facilitate program completion and shorten time to complete the program, graduate students are encouraged to complete their iPOS in their <u>first semester</u>. Students who have not completed their iPOS by the time they have enrolled for 50 percent of the minimum credit hours required for their degree program will receive a registration hold. No student will be allowed to register for the culminating experience without an approved and up-to-date iPOS on file.

If a student needs help with filing the iPOS, the student can download the <u>iPOS How-To Guide</u>, visit the <u>iPOS</u> website, OR contact their Graduate Staff Advisor for assistance.

Your iPOS will be reviewed by faculty and staff to ensure that it meets the Academic Requirements as outlined in the degree requirements of this handbook.

All courses that appear on the iPOS are applied toward the online MS in Psychology degree and are ineligible to be applied toward a future graduate degree. As such, we recommend students list only the 36 credits required for the degree on the iPOS.

### Course Sequences & Registration

It is recommended that you keep a copy of the advising checklist for your admit term that is available on the advising website easily accessible and review it as you register for courses each semester.

We strongly encourage you to complete the core courses when they are offered. These courses may only be offered during certain semesters and sessions each calendar year and if you do not take them when they are offered it may significantly delay your time to degree completion.

Students can find recommended course sequences for their start term on the MS Psychology Online – Advising Website under the "Registration & Degree Progress" tab and choosing the appropriate admit term.

Each semester you will register for classes electronically via My ASU. You can view the schedule of classes online <a href="here">here</a>. To find out when classes are available and when you must register please visit the <a href="ASU Academic Calendar">ASU Academic Calendar</a>.

Graduate students are required to maintain continuous enrollment. This means that you must be enrolled in a minimum of one credit hour of graduate level coursework each fall and spring semester. Read the full policy on page 11 of the <u>Graduate College Policy Manual</u>.

# Transferring Between Online and Ground MS Psychology

A ground MS student who chooses to transfer to the online MS program needs to discuss this decision with his/her advisor and the Program Director in order to review its potential professional and economic implications.

In order to change the program, the ground MS Psychology student can change the program internally through their My ASU account. There is a \$30 program change fee required by the Graduate College. Students are allowed one change per application with no time limit, as long as the student never deferred his/her original offer of admission. This is considered a plan change within ORG (i.e., CSOC&BEH). Preadmission rules are relaxed for this type of change.

Campus transfers are allowed from ground to online, **BUT not online to ground**. If a student seeks to transfer from the online to the ground MS Psychology program, the student would require a new application (as the requirements for the application and admission are different).

In terms of course credit transfers, *ground MS students who transfer to the online MS program* will be allowed to transfer a maximum of 12 course credits, with the exception of Research (PSY 592), Applied Project (PSY 593), and Thesis (PSY 599). Additionally, although students who transfer may want to continue doing research with their former ground advisor, they cannot receive course credit for it in the online MS program as research is not a part of the curriculum.

In terms of course credit transfers <u>from the MS online program to the MS ground program</u>, a maximum of 9 elective credit hours of coursework from the MS online program can transfer to the MS ground program. If a student completed PSY 500 and PSY 515, both courses will not be transferable and the student will need to retake PSY 500 and PSY 515 in the ground modality.

Finally, students must be continuously enrolled in the MS Psychology program (either ground or online) until they graduate. Thus, if no courses are offered for the student's Plan of Study (POS) the semester after their program change (not including summer), they will need to enroll in one credit to have continuous enrollment.

# Satisfactory Academic Progress Policy

It is the responsibility of the graduate student to be aware not only of the program's requirements, but also policies set in place by the Graduate College. Students are required to be aware of and understand the current <u>ASU Graduate Policies and Procedures</u>, the New College of Interdisciplinary Arts & Sciences <u>Satisfactory</u> Academic Progress Policy, as well as any policies outlined in this manual.

In addition to requirements outlined in New College Satisfactory Academic Progress Policies students must achieve a grade of "C" or higher in all *required courses* that appear on the approved iPOS (required courses are listed in the <u>ASU Academic Catalog</u>). A student who receives a "D" or lower in a core course in their program must repeat the course in a regularly scheduled (not an individualized instruction) class. Although only the "C" or higher can be included on the iPOS GPA, both grades will be used to compute the Cumulative GPA and the Overall Graduate GPA.

### Student Code of Conduct

All students are expected to adhere to the <u>Arizona Board of Regents Student Code of Conduct</u> and university policies and procedures.

Students are expected to regularly check their ASU email accounts for messages from the university and New College. Students also are expected to regularly check their My ASU priority tasks for messages and holds from the university. Students are responsible for managing their tuition payments, finances and tracking university academic calendar deadlines.

# **Academic Integrity**

The highest standards of <u>academic integrity</u> and compliance with the university's <u>Student Code of Conduct</u> and <u>Academic Integrity Student Policy</u> are expected of all graduate students in academic coursework and research activities. # My ASU Portal

On your My ASU portal you will find information about your courses, transcripts, transportation, student success and support, finances, university policies and the academic calendar. Please take time to familiarize yourself with these areas:

**Profile:** Update your address, phone number, email information, or add guests, such as a parent, so they can look at FERPA-protected information including grades.

My Classes: Click on the name of each course to access the corresponding Canvas content. This is where you will see the syllabus, find links to readings and submit assignments. Take a few minutes to familiarize yourself with the structure of each course.

**Final Transcript**: If you sent in a transcript for admission to the program before you graduated, send your final transcript with your degree posted.

**Academic Integrity Module**: ASU Graduate College module reviewing academic integrity expectations. Please complete this as soon as possible. Please note, this module explains the university-wide policy. The New College academic integrity policy includes additions specific to our students. Please be familiar with both policies.

Academic Calendar: This has important dates you need to monitor, including when classes begin, last day to register or drop/add classes, tuition and fee payment deadlines, holidays, withdrawal deadlines, schedule of classes available and when to enroll.
